## The Children and Young People's Trust...

- From 01<sup>st</sup> October 2006 all children's services –
  including schools will be provided by the Children and
  Young People's Trust;
- The CYPT brings together what was Children, Families and Schools with South Downs NHS Health Trust's Children and Families Services;
- The CYPT will work in partnership with other health services, and the city's voluntary and community sectors;
- The city will be divided into three Areas Central, West and East. Each Area will have its own teams, although some services will be city-wide.

### The commitment...

- The CYPT aims to promote inclusion and equality of opportunity and seeks to eliminate discrimination against minority and disadvantaged groups;
- The vision for Area working is based on empowering communities of schools to create a new learning culture that will benefit individual students and their communities as a whole;
- Effective responses to equalities issues and promoting and protecting the welfare of all children and young people is a responsibility shared by all schools across the city.

### The new Ofsted inspection framework makes specific judgements on...

- The extent of learners' spiritual, moral, social and cultural development;
- How well learners with learning difficulties and disabilities make progress;
- The behaviour of learners;
- The extent to which learners make positive contributions to the community;
- How well provision promotes the well-being of learners;
- How well equality of opportunity is promoted and discrimination tackled so that all learners achieve as well as they can;
- Action (is) taken to reduce anti-social behaviour, such as bullying and racism.

### The CYPT...

- Offers consultant support for school improvement and a range of services supporting equalities for children and families;
- Monitors levels of bullying and harassment in schools and reports annually to members;
- Prioritises equalities across the Children and Young People's Plan;
- Has undertaken a three-year round of Equalities Impact Assessments to establish provision and identify need;
- Is focused on outcomes for children and young people.

# So, what is happening in school?

### **Equalities Priorities**

- Supporting schools in developing new Disability Equality Schemes 2006, and preparing for Gender Equality legislation in 2007;
- Developing the work programme of the CYPT's Homophobic/Transphobic Bullying Working Group;
- Extending the number of schools achieving Healthy School Status to 100% by 2008;
- Promoting children and young people's participation in work to counter bullying and harassment;
- Monitoring the performance of schools through the termly racist incident summaries and the published findings of Ofsted inspections;
- Providing support and resources to enable schools to engage children and young people in marking events within the Equalities Calendar.
