## 13. LEARNING DISABILITY COMMISSIONING STRATEGY

- 13.1 Board members received a presentation with slides on Learning Disability Services and the preparation of a Learning Disability Commissioning Strategy (copy of slides attached).
- 13.2 Dr Peter Wilkinson, Consultant in Public Health, spoke on the epidemiology of Learning Disability and Simon Scott, Assistant Director Service Improvement, spoke on Models of Care.
- 13.3 Kate Money Programme Director for Health and Social Care reported that there was a need to agree a commissioning strategy for Learning Disabilities in order to put in place a structure to manage service planning and the commissioning process. A re-commissioning timetable was required for the next two years and it was necessary to be clear on which services should be re-commissioned. Ms Money's task was to ensure structures were in place and to provide reports for the Health and Social Care Programme Board.
- 13.4 A draft commissioning strategy had been produced by Ken Whitehouse and a summary with an attached action plan would be presented to the Board in September.
