6. LICENSING ACT 2003 - LICENSING PANEL

- 6.1 The Committee considered a report of the Director, Strategy and Governance that sought formal approval of the establishment of its Sub-Committee, the Licensing Panel (see minute book).
- 6.2 Members were informed that one panel consisting of 3 Members would be established to deal with cases where a hearing is required under the Licensing Act 2003, and that all other Members of the Licensing Committee would be eligible to serve as substitutes on the Panel. In practice, it was advisable that four Members should be available at the start of each meeting, to cover the possibility of a Member having a prejudicial interest and therefore not being able to take part in the Panel.
- 6.2 The Chair informed Members that the Chair and Deputy Chairs had arranged to meet with officers to discuss the practical arrangements for setting up the Licensing Panel. Members of the Licensing Committee would be fully informed of these arrangements.
- 6.3 **RESOLVED** (1) That the Licensing Committee Licensing Act 2003, formally confirm the establishment of its Sub-Committee, the Licensing Panel in the terms agreed at full Council on the 22nd April 2004 and which are reflected in the terms of reference for the Licensing Panel in the Council's Constitution appended to the officers' report.
- (2) That the Chair, and two deputy chairs be appointed as the named Members of the Licensing Panel, with all other Members of the Licensing Committee eligible to serve as substitutes.
