Subject:	Terms of reference and constitution for the Brighton and Hove Hackney Carriage and Private Hire Consultation Forum

1. Purpose of the report

That committee approve the terms of reference and constitution for the Brighton & Hove Hackney Carriage and Private Hire Consultation Forum which has been amended to give greater representation from ethnic groups working in the Brighton & Hove hackney carriage and private hire trade.

2. Recommendations

2.1 That Committee approve the amended terms of reference and constitution for the Brighton & Hove Hackney Carriage and Private Hire Consultation Forum. (Appendix A)

3. Information/Background

- 3.1 The Brighton & Hove Hackney Carriage and Private Hire Consultation Forum has been operating for over 10 years following local government reorganisation. The Forum meets regularly (approximately every 6 weeks) to discuss proposals to change policy and procedures or practice in the licensing of hackney carriage and private hire vehicles and drivers in Brighton and Hove or which could benefit passengers.
- 3.2 It is recognised that ethnic drivers have been under represented on the forum and in order to increase representation of these drivers membership has been amended to allow representation from the Brighton Sudanese Taxi Forum. The Brighton Sudanese Taxi forum is not exclusively for Sudanese drivers and will represent any driver from other ethnic groups if requested.

3.3 The ethnic make up of taxi drivers provided from ethnic monitoring in 2005/06 is shown in Appendix B

<u>Terms of reference and constitution for the Brighton and Hove Hackney</u> <u>Carriage and Private Hire Consultation Forum</u>

1. Terms of reference and constitution for the Brighton and Hove Hackney Carriage and Private Hire Consultation Forum

- 1.1 The Consultation Forum shall be for the discussion of proposals to change policy and procedures or practice in the licensing of hackney carriage and private hire vehicles in Brighton and Hove or which could benefit taxi passengers.
- 1.2 That the Director of Environment will decide on which proposals and applications of general interest to the trade should go first to the Consultation Forum for consideration.
- 1.3 That meetings of the Consultation Forum shall take place on a regular basis (approximately every 6 weeks).
- 2. Membership.

That membership of the Hackney Carriage and Private Hire Consultation Forum shall be limited to two representatives from each group in the Brighton and Hove Hackney Carriage & Private Hire Consultation Forum as follows:-

- The Transport General Workers Union represents hackney carriage drivers and operators.
- GMB licensed Private Hire, i.e. Taxi Section represents GMB members.
- Private Hire Association represents private hire owners and drivers.
- National Provincial Taxi Trade Union (NPTTU) Local union representing Hackney Carriage owners and drivers.
- Brighton Sudanese Taxi Forum represents Sudanese hackney carriage and private hire drivers.
- Brighton and Hove Radio Cabs / Car Cabs represents B+H Radio Cabs & Car Cabs companies and drivers.
- Hove Streamline represents Hove Streamline Company and drivers.
- Brighton Streamline represents Brighton Streamline Company and drivers.
- Brighton & Hove City Cabs represents City Cabs Company & drivers.
- Taxi link represents Taxi Link Company & drivers.
- Sussex Police.

And such officers from the council that are required to provide the necessary technical and administrative support.
