37. APPLICATION FOR A VARIATION UNDER TRANSITIONAL ARRANGEMENTS OF THE LICENSING ACT 2003 - SIR CHARLES NAPIER, 50 SOUTHOVER STREET, BRIGHTON

- 37.1 The Panel considered a report of the Assistant Director, Public Safety concerning an application for a variation under transitional arrangements of the Licensing Act 2003 Sir Charles Napier, 50 Southover Street, Brighton (for copy see Minute Book).
- 37.2 The applicant Jerrard Martin (Licensee) and the Area Manager, Paul Chatfield attended the Panel.
- 37.3 The Licensing Manager outlined the details of the application and noted a typographical error in the report in respect of opening hours at section 'O'. The report read 'Friday -Sunday 10.00-01.00' and should have read 'Mon Thu 0700 0000 and Fri Sun 0700 0100'. The Panel accepted the amendment.
- 37.4 Mr Martin and Mr Chatfield set out their case for the application, noting that they had met or spoken with the majority of the objectors in an effort to alleviate any fears raised. They advised that the majority of visitors to the business were local residents and did not drive to the venue. Further, that the garden was closed at 22.00 and that music, other than the occasional live, folk musician was not played in the premises.
- 37.5 The Panel and Applicants discussed the concerns of objectors and agreed that; 1) Doors and windows to be closed after 23.00 if live music in progress. 2) External lights on the premises to be dimmed at 23.00 hours.
- 37.6 **RESOLVED** That a variation to the premises licence already granted under 'grandfather' rights be granted with the following conditions.
- 1) Doors and windows to be closed after 23.00 if live music in progress.
 - 2) External lights on the premises to be dimmed at 23.00 hours.
