3. Scrutiny Reviews currently in Progress

eb4U Scrutiny Panel

- 3.1 The 5-Member eb4U scrutiny panel comprising Councillors Jan Young (chair) Kevin Allen, Brian Pidgeon, Roy Pennington, David Watkins has met four times in public. Information has been given by eb4U, residents and members of the community, a representative of Government of the South East and council officers.
- 3.2 Further meetings are to be held at 10am on Monday 6th June (Hove Town Hall), Monday 20th June (Brighton Town Hall) and Monday 4th July (Hove Town Hall) and additional meetings are likely to be needed before the Panel agrees its report.

Comart and Schools pfi
