1. DECLARATIONS OF INTEREST

1.1 No declarations of interest were made.

2. MAYORAL REPORT 2006-2007

- 2.1 The Mayor moved that the Mayoral Report for 2006-2007 be received.
- 2.2 The motion was carried.

3. ELECTION OF THE MAYOR OF THE COUNCIL FOR THE MUNICIPAL YEAR 2007/2008

- 3.1 The Mayor having invited nominations for the position of Mayor of Brighton & Hove City Council for the municipal year 2007/2008 the following proposal was submitted:-
 - Councillor Mrs. Carol Theobald proposed by Councillor Mrs. Mears, seconded by Councillor Oxley.
- 3.2 The Mayor declared that, there being no other nominations, Councillor Mrs. Carol Theobald be duly elected Mayor of Brighton & Hove City Council for the forthcoming municipal year. Councillor Mrs. Theobald then made and

signed the Declaration of Acceptance of Office.

3.3 The Council agreed.

- 3.4 The Mayor thanked the Council for her appointment.
- 3.5 Councillor Theobald moved a Vote of Thanks to Councillor Smith, the retiring Mayor. The Motion, which was seconded by Councillor Oxley, was carried.
- 3.6 The Mayor presented Councillor Smith and Mrs. Pat Smith with commemorative badges in recognition of their year of office.
- 3.7 Councillor Smith thanked the Council.

4. ELECTION OF THE DEPUTY MAYOR OF THE COUNCIL FOR THE MUNICIPAL YEAR 2007/2008

- 4.1 The Mayor moved that the Council appoint Councillor Smith as Deputy Mayor for the forthcoming municipal year. The Motion was seconded by Councillor Oxley.
- 4.2 The Mayor declared that, there being no other nominations, Councillor Smith be duly elected as Deputy Mayor of Brighton & Hove City Council for the forthcoming municipal year.
- 4.3 The Council agreed.
- 4.4 Councillor Smith made and signed his Declaration of Acceptance of Office.

 The Mayor presented the Deputy Mayor with his badge of office.

5. MINUTES

5.1 **RESOLVED** – That the minutes of the meeting of the Council held on 8 March 2007 be approved and signed as a correct record of the proceedings.

6. MAYOR'S COMMUNICATIONS

- 6.1 The Mayor informed the Council that Reverend Felix Mascarenhas had consented to be her Chaplain for the forthcoming year and that Reverend David Wostenholm had consented to be her Deputy Chaplain for the forthcoming year.
- 6.2 The Mayor reported that the Mayoral Charities for her year of office would be the Martletts Hospice, The Pink Dolphin and Whoopsadaisy for physically disabled children.

6.3 The Mayor also brought to council's attention the plight of Madeline McCann and her family and invited all Members to complete a book of personal messages which she would then send to Madeline's family.

6.4 The Mayor invited all Members of the Council to attend the Civic Eucharist Service at All Saints Church, Hove on Sunday, 31 May at 9.30am.

8. REVIEW OF THE CONSTITUTION

- 8.1 The Mayor stated that the next item on the agenda was report of the Chief Executive, concerning the review of the Constitution and proposed changes to the committee structure.
- 8.2 Councillor Taylor stated that he wished to raise his concern over the proposed changes which resulted in two new sub-committees and the elevation of the Culture & Tourism Sub-Committee into an Executive Committee as the Culture, Recreation & Tourism Committee. He believed that such proposals should have been considered fully by the Policy & Resources Committee and proper consultation undertaken rather than simply bringing the matter to council at such a meeting. He suggested that the matter should be deferred and taken to the next Policy & Resources Committee in June. There were anomalies in respect of the size of the various committees and sub-committees which had not been addressed and in his view should be e.g. both the Adult, Social Care & Health Committees had 10 members, whilst Environment, Housing and the new Culture Committee had 11.
- 8.3 Councillor Watkins stated that he was also concerned about the need for the report to come to the present meeting and the lack of consultation over the

proposals. He noted that a Bill was currently being considered by Parliament which could affect the governance arrangements of the authority and therefore did question the need for additional committees to be established at this point in time. He also agreed with Councillor Taylor in that a report should be considered by the Policy & Resources Committee in the first instance.

- 8.4 Councillor Oxley noted the comments and stated that the new Administration was keen to take the city and the authority forward and a key part of this was highlighted by the establishment of the two sub-committees for Major Projects and Finance Management. He also believed that the Culture, Recreation and Tourism Committee would indicate to the various partner organisations and those involved in the city's tourism economy the council's commitment to developing this important area. He had contacted the various Group Leaders about the proposals and hoped that they could now be supported and moved that the recommendations be agreed.
- 8.5 Councillor Taylor requested that a recorded vote be taken which was supported by the requisite number of Members and in accordance with Procedural Rule 28.2 a recorded vote was taken on the report's recommendations.
