For General Release

1. This update report supplements the report on the Cabinet agenda and identifies the need to amend recommendation 2.3 in view of the need for matters affecting school admissions to be considered by the full Council.
2. Owing to changes in the delegated authority for school admissions decisions agreed by Council in December 2011, the final decision regarding this proposal will have to be made by full Council.
  - 2.1 Recommendation 2.3 should therefore be amended to read  
  
"That the final decision on the above proposal be made by full Council at its meeting on the 19<sup>th</sup> July 2012, following the end of the statutory notice period and that any responses received in respect of the statutory notice be reported to Council in July 2012."
3. Owing to the timing of the end of the consultation period and the timetable for the preparation of Cabinet reports the results of the consultation have changed since the publication of the Cabinet report. The consultation period ended on 2<sup>nd</sup> May 2012 and the final results are as detailed below.

**St Nicolas Church of England Junior School.**

A total of 11 responses were received of this 10 were in favour and 1 was against.

**Portslade Infant School.**

A total of 56 responses were received of this 54 were in favour and 2 were against.

**St Peter's Community Infant School**

A total of 14 responses were received of this 14 were in favour and none were against.
