Since living in Kingswood I have had little to no sleep at the weekends due to the amount of 'through traffic heading to and Licensing home from the Ocean Rooms.

People have been known to stop and urinate in our covered outdoor bin sheds and also use the bin sheds to take what appear to be drugs before heading down Morley Street to the Ocean Rooms. I have on occasions asked these people not to use the bin sheds for these purposes and have also on occasions been told in no uncertain terms to f\*\*\* off!

Usually on Thursday, Friday and Saturday nights I have been awoken by the same drunken people falling over in the play area's of our flats, screaming and shouting, falling over laughing and being a general nuisance to most residents in Kingswood and Milner.

As I live on the Northern end of Kingswood I get to here these people not only drunk on their way there but also on there way home.....this, on occasions, being as late/early as 5am.

Also as there is now a no smoking policy in the building we have had to endure the shouting of people outside of the club and the music levels can be heard from my bedroom with the windows shut.

Although I am in no way opposed to people having a good night out I am opposed to having broken nights sleep at the weekends by drunken people staggering through between the two blocks of flats shouting what a wonderful night they have had.

The Ocean Rooms have had no consideration for its neighbouring properties and to advertise as an "After Club Club" in a residential area in my opinion is ridiculous.

There have been 3 deaths to my knowledge outside this club. Is this not enough?

### TO WHOEVER IT MAY CONCERN

I am a resident who lives in the far north end of Milner flats Brighton, on the corner of Nelson Row and Morley Street.

Throughout the summer and up until New Years Day I have had nothing but despair from the noise of music and the people who frequent the Oceans Rooms nightclub. I have had hardly one night's full sleep and this has become detrimental to my health.

I have had to have the noise nuisance department actually stand in my bedroom monitoring the noise from this club at 1.30am!

I have brief dates of this noise nuisance:

Sunday 7<sup>th</sup> June 2009: Music blaring from the club, finally quietened down at 7.15

Monday 8<sup>th</sup> June 2009: Spoke to Environmental Health department to complain of the volume of music and individuals from the club.

Monday 22<sup>nd</sup> June 2009: Music blaring from the club, finally quietened down at 12.30am

Sunday 2<sup>nd</sup> August 2009: Music blaring from the club, finally quietened down at 6.30pm

Saturday 12<sup>th</sup> September 2009: Music blaring from the club most of the night. Extremely loud, very little sleep.

Friday 25<sup>th</sup> September 2009: Music blaring from club most of the night.

Saturday 26<sup>th</sup> September 2009: Music blaring from club most of the night. Extremely loud, very little sleep.

Monday 28<sup>th</sup> September 2009: Music blaring from club most of the night.

Thursday 1<sup>st</sup> October 2009: Telephoned the police

12.15 – 12.30am due to extreme noise and 150+ people emitting City Council extreme noise from the club.

2 7 JAN 2010

Friday 2<sup>nd</sup> October 2009: Telephoned Council – Edward Bulger to report / complain about noise from the club.

Friday 23<sup>rd</sup> October 2009: Extreme noise, music and individuals, from the club. Noise finally quietened down 2.15am.

Saturday 24<sup>th</sup> October 2009: Had to telephone noise patrol at 1.45am

<u>Friday 30<sup>th</sup> and Saturday 31<sup>st</sup> October 2009</u>: Extreme noise, music and individuals, had no sleep as the music was blaring out from 1.30am until 5.15am

<u>Thursday 31<sup>st</sup> December 2009</u>: No sleep, extreme noise, music, screaming, shouting all night.

This is just a brief diary of events I have to deal with every weekend, and as you can see from the summer months, most weekdays too.

This had gone on for over a year now and I am literally at my wits end.

Another mans life has been lost at this venue; I believe this to be the 3<sup>rd</sup> life lost there.

Since the club has been closed I have actually managed to sleep at night and am no longer awoken by drunken yobs outside of my window on there way to and from the club.

It is just such a shame that a man had to die for the licensing department and police to realise that this club needs to be closed for good. This is a highly populated residential area and I cannot see why a club like that should be on peoples doorsteps.
