#### REASON FOR THE DECISION

The Local Government and Housing Act 1989 requires each Local Authority to formulate proposals relating to income from rent and charges, expenditure on repairs, maintenance, supervision and management and any other prescribed matters in respect of the HRA. In formulating these proposals using best estimates and assumptions the Authority must set a balanced account. This budget report provides a breakeven budget and recommends rent increases in line with current government guidance.

#### DETAILS OF ANY ALTERNATIVE OPTIONS

There are no alternative options proposed. Rents are set in accordance with the Government's rent restructuring guidance and increases are in line with the Housing Subsidy Determination. The Housing Subsidy Determination controls rent setting by removing resources from local authorities through non compliance.

The budget proposals also includes maintaining the current service provision with improvements as identified in the Service Improvement Plan and investment in priorities such as Turning the Tide strategy. It is possible for alternative options to be considered such as increasing or reducing service provision which would result in a

reduction or increase in the revenue contributions to the capital programme. However, officers recommend that the budget proposals provide the appropriate service provision whilst ensuring that the revenue contributions to capital are in line with the current HRA Business Plan.

#### REASON FOR THE DECISION

Given the close links between strategic housing, major infrastructure projects and economic regeneration, it is proposed that the housing functions currently discharged as part of the Adult Social Care & Housing Directorate be transferred to the Directorate of Culture & Enterprise. This will enable greater co-ordination and synergy between strategic housing (which includes private sector housing, homelessness, allocations and standards of housing) and economic regeneration. The shortage of housing nationally and, more importantly, the challenges faced by the City, mean that there is a need to co-ordinate more closely our approach to meeting housing needs with our approach towards major infrastructure/ building developments and better use of public sector land assets. The availability of affordable housing also plays a key role in the overall state of the local economy and, in particular, employment.
