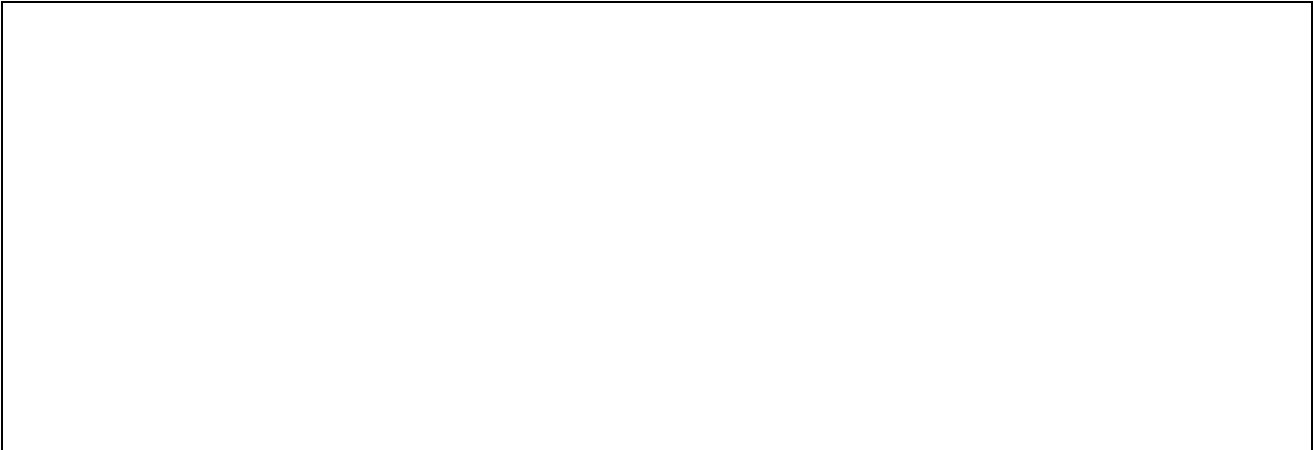
The closing date for receipt of public questions and deputations for the next meeting is 12 noon on the fifth working day before the meeting.
