



13 CHAIR'S COMMUNICATIONS

- 13.1 The Chair explained that she had met with Chief Inspector Di Lewis and Chief Inspector Lisa Bell and that these meetings had done much to reassure her about the revised structure within the Police Licensing Team which had come into operation in September. The new arrangements appeared to be working well and a good working relationship had been established with the Council's own Licensing Team.
- 13.2 Improvements had been made to the internal layout of "Pryzm" in line with approvals granted at a Licensing Panel hearing and a successfully managed "safe space" had been provided at "Shooshh" where all entering that club had to pass through scanners."Tempest was another club in the city which was also well managed.
- 13.3 Operation of robust policies in the city which were sensitively applied and the level of training required by establishments and provided to Members had been widely acknowledged. The city had been recognised as a "Beacon Authority" and had been consulted on and had taken a pro-active part in changes to be implemented to the existing Gambling Act legislation. The aim of the current review was to strike the right balance. There had been media interest in a number of issues in relation to licensing issues over recent months and the opportunity to discussion germane issues had been welcomed.
- 13.4 Elsewhere on the Agenda an update would be provided in relation to the House of Lord's Select Committee report and the Government's response to it. Some very sensible recommendations had been made by the Government, particularly in relation to TEN's and training for both licensing committee members and the police. The Chair was delighted to be able to report that the impractical idea of planning committees taking over the role of licensing committees had been dropped.

17 HOUSE OF LORDS SELECT COMMITTEE - REVIEW OF THE LICENSING ACT 2003

- 17.1 The Committee considered a report of the Executive Director of Neighbourhoods, Communities and Housing detailing current progress in relation to the workings of the House of Lords Select Committee review of the Licensing Act 2003.
- 17.2 It was noted that The Select Committee on the Licensing Act 2003 had been set up on 25 May 2016 with the task of conducting post-legislative scrutiny of the Act. Their report was published in April 2017, and had made a number of far reaching recommendations for the Government to consider. A summary of the report and a link to the full report had been circulated to members on the 6 April 2017, inviting officers and members to submit their comments to the Institute of Licensing who would be gathering views on the recommendations within the report and would report on their findings in due course.
- 17.3 A Government Response to the Select Committee report was expected within 2 months of the report being published but had only just been published (6 November). The Government had rejected the headline proposal to merge planning and licensing and there would be limited legislative change. Notwithstanding that the Select Committee recommendations carried considerable weight that did not mean that the Government/ Departments had to accept them, or act on them (at all or within a specified period of time). There would however be a debate in the House about the Government's response, which would highlight any dissatisfaction that the Committee/Lord Chairman might have with the responses to particular recommendations.
- 17.4 Councillor Morris welcomed the proposals in respect of TEN's and the Chair, Councillor O'Quinn concurred stating that as conditions could not be applied to a TEN as it stood that could be problematic.
- 17.5 Councillor Simson stated that she wished to highlight the fact that information should be published where cases were settled out of court. It could be extremely frustrating when Panel's had engaged in lengthy consideration of an application and she wished to receive clarification regarding the ability of the council to do this and how such a process could be effectively managed. The Legal Adviser to the Committee, Rebecca Sidell,

explained whilst this approach had initially been supported by Government it now appeared unlikely that this would be carried forward. The Public Health, Licensing Lead, Jim Whitelegg, stated that generally as good practice, over and above the Decision Notice, parties were generally advised of the reasons when cases were settled out of court although this was not always the case.

- 17.6 In answer to questions relating to the Late Night Levy it was explained (although confirmation of this was still awaited), that this concept had been revisited and it seemed likely that this could be applied to a target area rather than applying to a whole district. This would provide a more finely honed response, although it would reduce the potential revenue streams available. Officers were watching this matter closely and would report further when the position became clear. It was also intended that officers of the Public Health Team would provide a presentation at the next scheduled meeting of the Committee detailing their work and updating on current legislation in relation to it.
- 17.7 **RESOLVED –** That the Committee receives and notes the contents of the report, and that officers will report back when legislative and guidance changes have been finalised.

18 SCHEDULE OF REVIEWS

- 17.1 The Committee considered the Schedule of Reviews for the period from June 2017 prepared on behalf of the Executive Director of Neighbourhoods, Communities and Housing.
- 17.2 **RESOLVED –** That the contents of the Schedule be received and noted.

19 SCHEDULE OF APPEALS

- 19.1 The Committee considered the schedule of appeals prepared on behalf of the Executive Lead for Strategy, Governance and Law for the period from June 2017.
- 19.2 Councillor Deane referred to skill and care of Panel's in arriving at their decisions, particularly in the case of Review Hearings, expressing concern that the Structures currently in place and established over a long period of time could be compromised due to a diminution of police resources. Councillor Simson echoed those concerns. The Public Health Licensing Lead, Jim Whitelegg, stated that officers had also had similar concerns but had however been greatly reassured as a result of on-going meetings which had taken place, particularly over recent weeks with representatives of the Police.
- 19.3 The Chair, Councillor O'Quinn confirmed that she had attended some meetings and that these had significantly reduced her concerns. Overall, the robust policies in place had resulted in a consistent approach and the licensing authority appeared to have a high success rate when defending appeals. Councillor Cattell stated that up to most up to date information on appeals and reviews seemed to bear indicate that was the case, which was very encouraging.

Formal request to include Central Hove Ward in the Special Stress Area as set out in the Brighton and Hove Statement of Licensing Policy 2016

Please add Central Hove Ward to the Special Stress Area as set out in the Brighton & Hove Statement of Licensing policy 2016 (as defined in paragraph 3.2 of the Statement of Licensing Policy).

In considering this request, please note;

- Crime mapping and alcohol related health statistics show there is significant alcohol related harm in the ward (Public Health Framework for Assessing Alcohol Licensing, Public Health Intelligence, October 2017)
 - a. Central Hove ranks 5th worst in the city for alcohol suspected ambulance call-outs (page 6)
 - b. Central Hove ranks 4th worst in the city for A&E attendances with a record of alcohol (page 6)
 - c. Central Hove ranks 4th worst in the city for alcohol related mortality (page 6)
 - d. Central Hove ranks 3rd worst in the city for alcohol specific admissions,
 - e. Central Hove ranks 5th worst in the city for Police recorded alcohol related issues.
 - f. Neighbouring Brunswick & Adelaide Ward, much of which sits in the Cumulative Impact Area fares better (ie less badly) against all of these metrics.
- 2. The maps set out in the Public Health Framework for Assessing Alcohol Licensing, Public Health Intelligence, October 2017 shows;
 - a. More than half of Central Hove is a medium ranking hotspot for police recorded alcohol related incidents
 - b. Much of the ward shows the same concentration of police recorded violence against the person offences as Brunswick & Adelaide Ward which sits in the CIA.
 - c. Nearly all of the ward shows a medium level of police recorded criminal damage offences, the same as much of the existing SSA.

- d. Much of the ward is blighted y noise complaints regarding licenced premises
- 3. There is a concentration of anti-social behaviour and alcohol and substance misuse related disturbance is a number of roads in Central Hove. There are emergency accommodation premises (some of which are entirely unsupported), a children's home, two Equinox run homes for women recovering from alcohol and substance misuse, two hostels for stag/hen-dos and people needing emergency (self-supported) accommodation.
- 4. George St, the twitten to Tesco car park and the churchyard of St Andrew's Church are blighted by aggressive begging and street drinking. There are two primary schools in close proximity; St Andrew's CE Primary and West Hove Connaught Rd site.
- 5. I refer members to the Annual Licensing Committee Report 2016 showed that Central Hove has a total of 82 licensed premises, which made it the 4th highest number in the city. With 16 'pubs bars and nightclubs' the ward is 5th highest in number and has 2 more than Brunswick & Adelaide which sits in the CIA.

1. SUMMARY AND POLICY CONTEXT:

- 1.1. This report sets out the licensing and gambling functions for Brighton & Hove City Council carried out during 2017.

3. RELEVANT BACKGROUND INFORMATION/CHRONOLOGY OF KEY EVENTS:

3.1. **Licensing Act 2003**

3.1.1. At the time of writing this report the total number of licensed premises and club premises in Brighton & Hove is 1392 and 34 respectively.

- 3.1.2. Table 1 below shows the numbers of applications and hearings for the last three years, including those granted, refused and withdrawn.
- 3.1.3. The Licensing Authority dealt with 3 reviews in 2017. The full list can be seen in the Review table report. 2 licences were revoked including International Food & Wine and Ideal Market. 5 appeals of the licensing authorities decision were or are being dealt with, including Tipple (appeal dismissed), Azure (license transferred), Coldean (condition modified by agreement), Ideal Market (appeal dismissed) and International Food & Wine (pending) (see Appendix 1).
- 3.1.4. In Appendix 2 you will find more detailed tables showing "Total Premises Licences by venue type and ward" and "Licence Applications received 2017 venue type and area" (Please note appendix 3 includes same tables for 2016).

3.1.4 In 2017 a total of 79 new premises applications were received, 76 of which were fully processed between 01.01.17 and 31.12.17. Processing means receiving the application, entering it onto the database, receiving representations and

proceeding to a panel hearing, sending out the panel decision letters, writing up the licences, sending out the licence and entering the decision onto the database. There can be some applications received near to the year end that might be counted as an application received but not as an application fully processed (because of 28 day consultation period, 20 day hearing period etc).

3.1.5 Headline trends

There was an increase in the number of applications received in 2017. Although there was an increase in café bar applications, there was a decrease in both pub/bar/nightclub and restaurant applications.

3.1.6 Of the 79 applications received during 2017, 33 were for premises within the CIZ and 9 were in the special stress area. 9 applications were for time limited licences (e.g. Sussex University, Jubilee Sq Xmas market and the Ice Rink) – 3 of which were in the CIZ. Looking at the 33 premises within the CIZ, 6 were granted after representations had been withdrawn & agreements reached, 18 were granted after no representations were received, 3 were refused, 3 were granted after a panel hearing and 3 are pending.

3.2. Gambling Act 2005 - Licensing Authority Functions

- 3.2.1. The functions of licensing authorities may be divided roughly into five: publication of Gambling Policy, regulation of premises, registration of small society lotteries, maintenance of registers and compliance.
- 3.2.2. Table 2 shows types and numbers of gambling licences issued by Licensing Authority currently compared to 2007 when the Gambling Act 2005 came into force.

3.4. Local Licensing Issues

3.4.1. Alcohol Programme Board

The Alcohol Programme Board includes health commissioners and NHS/voluntary sector providers, the Council, University student reps, police, licensees, retailers and probation services, with Chair of Licensing invited. The work of the Alcohol Programme Board, domain group 2 (availability) developed an action plan which can be found at Appendix 4.

3.4.2. Street drinking/Sensible on Strength

- Membership = 163 SOS website
- Further 39 stopped selling but not joined scheme.
- Dr Worthley, Lead GP at Brighton Homeless Healthcare, "continues to be one of the most significant public health measures in Brighton & Hove"
- SoS scheme continues to generate a lot of interest from other authorities who have visited B&H to find out how we run the scheme.

3.4.3. Safeguarding in the Night-Time Economy

The licensing authority continues to support safeguarding initiatives such as the Beach Patrol Quad bike, safe space and street pasters. A workshop for interested parties, looking at future proofing funding for these initiatives was held on the 21st February 2017. Members attended the tour of the night time economy, facilitated by the police licensing unit. Action Plan and Community Safety strategy have been agreed by Full Council. The Safe in the City board will oversea the Community Strategy and Action Plan as part of their remit but we will provide updates to Licensing Committee with regard to the Action Plan and keeping safe in night time economy.

3.5. Gambling Local and National Issues

Following the publication of the revised Gambling Policy in December 2016, the Licensing Team carried out routine Gambling inspections to our 39 Betting Office premises, 3 casino premises, 1 bingo and 11 Adult Gaming centres. This involved going through a comprehensive inspection form which looks at all the Mandatory conditions, including gaming machine entitlements and age restrictions, Social Responsibility Code Provisions and Codes of Practice under the Gambling Act 2005. Overall this was felt to be a successful operation with most premises being compliant and having good practices and procedures in place. We will be re-inspecting these premises on annual basis, ensuring that the operators have regard to the Council's Gambling Policy and Local Area Profile.

Brighton & Hove's gambling policies and practices has been highlighted by the Gambling Commission as an examples of good practice, in particular the work and links developed with Public Health to tackle gambling related harm. We recently asked to present at the Institute of Licensing Conference and a regional workshop to share the work we have been doing with Public Health.

This has been reported nationally, and I include below a quote from the Chair from a recent Gambling Commission press release and feedback from the recent presentations.

3.6 Gambling Commission Press release

Gambling businesses from across the south east of England are expected to attend a workshop aimed at ensuring their activity is safe and crime-free today.

Run by the Gambling Commission, with the support of Brighton and Hove City Council, the workshop at Civic Hall in Crawley will provide advice about tackling money laundering, and helping gamblers stay safe using local risk assessments and self-exclusion tools.

Local risk assessments help businesses ensure they have considered nearby risks when running their business – such as their proximity to schools and homeless shelters – and the self-exclusion scheme helps consumers who would like to take steps to stop gambling.

Representatives from the region's adult gaming centres, betting shops and bingo halls are expected at today's workshop.

Helen Venn, Programme Director at the Gambling Commission, said: "Raising standards across the whole gambling industry is at the heart of our latest strategy to shape a well-regulated gambling market that works for consumers.

"It's been a really important opportunity for us to engage with smaller operators on a face-to-face basis, but also to re-emphasise with gambling businesses the importance of taking their anti-money laundering and social responsibility requirements seriously."

While workshop sessions on common compliance, anti-money-laundering, and self-exclusion will be run by Commission representatives the session on local risk assessments will be supported by Brighton and Hove City Council.

Brighton and Hove City Council's Chair of Licensing, Jackie O'Quinn said: "BHCC recognises that certain groups are more vulnerable to gambling-related harm. With this in mind, we have developed a local area profile toolkit that helps operators carry out risk assessments and identify and help those who may be at higher risk of harm."
