1. SUMMARY AND POLICY CONTEXT:

- 1.1 The Children and Young People's Trust is developing a second Children & Young People's Plan (CYPP) for 2010-2013.
- 1.2 Local authorities have a statutory duty to produce a Children and Young People's Plan, with their partner agencies setting out the vision and priorities for children's services in their area to improve outcomes for children and young people.

2. RECOMMENDATIONS:

- 2.1 (1) That members agree to hold a one off workshop to consider and comment on the draft Children and Young People's Plan (CYPP).
- 2.2 (2) Potential dates for the workshop could be the 6-9 July or anytime after this up to 20 July.

3. RELEVANT BACKGROUND INFORMATION/CHRONOLOGY OF KEY EVENTS:

- 3.1 A preliminary document came to CYPOSC in December 2008 with the intention of presenting a final CYPP to full council in April 2009. In January 2009 the Director of Children's Services identified a number of factors which meant that the timetable had to be revised i.e.
 - new national guidance on the content of children and young people's plans issued in January 2009
 - capacity issues within the Children and Young People's Trust (CYPT) to complete the drafting process
 - details of the re-structure process within the CYPT could not be included until after July 2009

3.2 In summary the current position is that:

- The CYPT has engaged a consultant to support the senior management team to complete the drafting process
- A final version of the CYPP will be presented to full council in October 2009 and to the CYPT Board in September 2009, which precludes consideration by CYPOSC at its September meeting
- A draft CYPP will be considered by the CYPT senior management team on June 25th, which precludes consideration by CYPOSC at its 17th June meeting
- It is therefore proposed to convene a one off workshop between 6th and 20th of July in order to ensure that the views of CYPOSC are fed into the consultation and drafting process
