

Reform of Education for young people aged 14-19 years

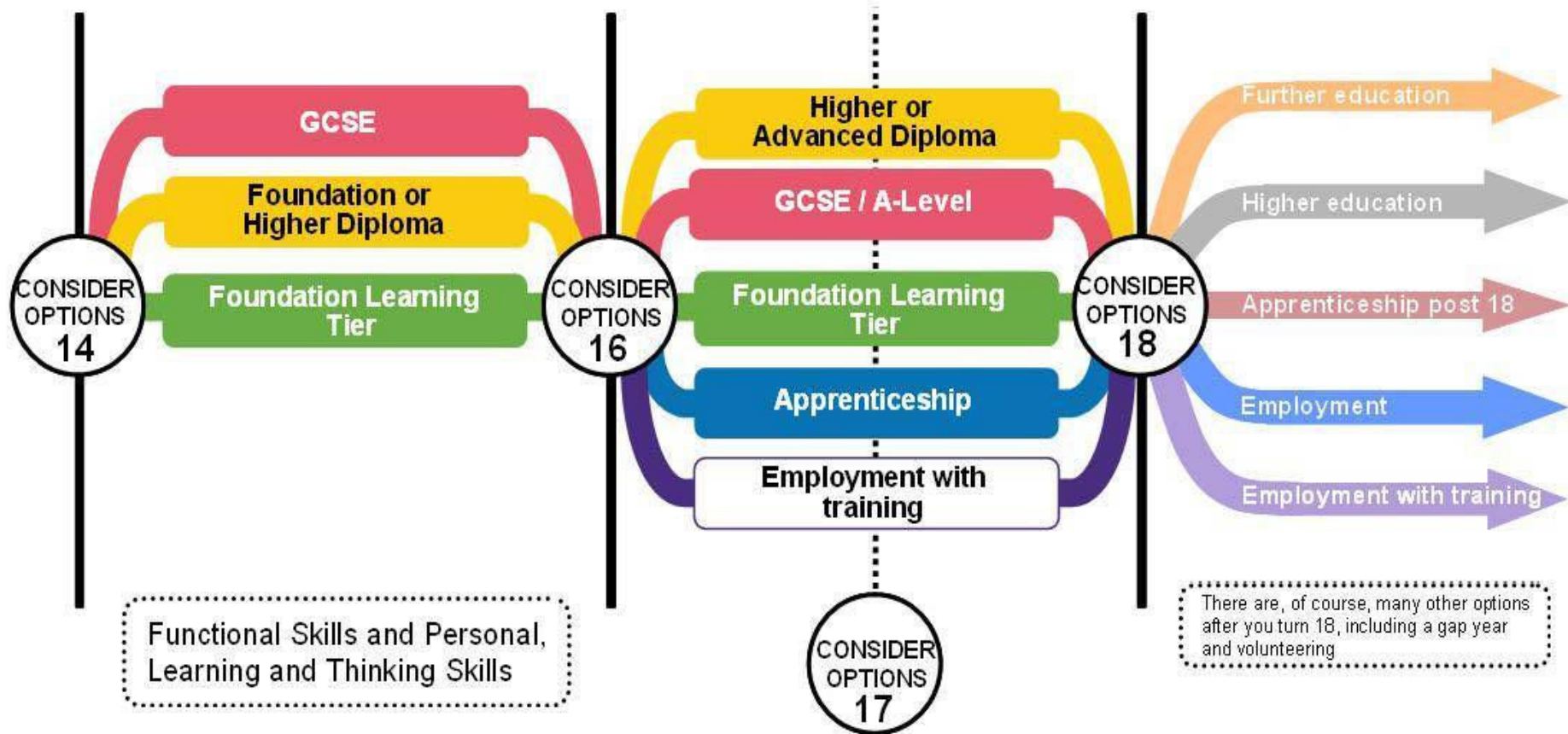
Overview

- Local authorities to be responsible for the integrated commissioning of all services for young people 0 -19 (25 if learners have learning difficulties and/or disabilities) so as to improve outcomes for all young people
- more young people to stay in education and training until age 18
- DCSF aims are:
 - at least 85% of 19 year olds to achieve level 2 qualifications by 2013 (*up from 73.9% 2008*)
 - at least 56% to achieve level 3 by 2012; (*up from 48% 2008*)
 - to reduce the proportion not in education, employment or training from 10% to 8% by 2010;

DCSF priorities

- Improving the curriculum and ensuring clear progression routes
- Establishing effective local collaboration of partners to deliver the curriculum and other services
- Re-organising the delivery system ensuring that local authorities, are the single point of accountability for all 0-19 Children's Services, and undertake strategic commissioning of provision

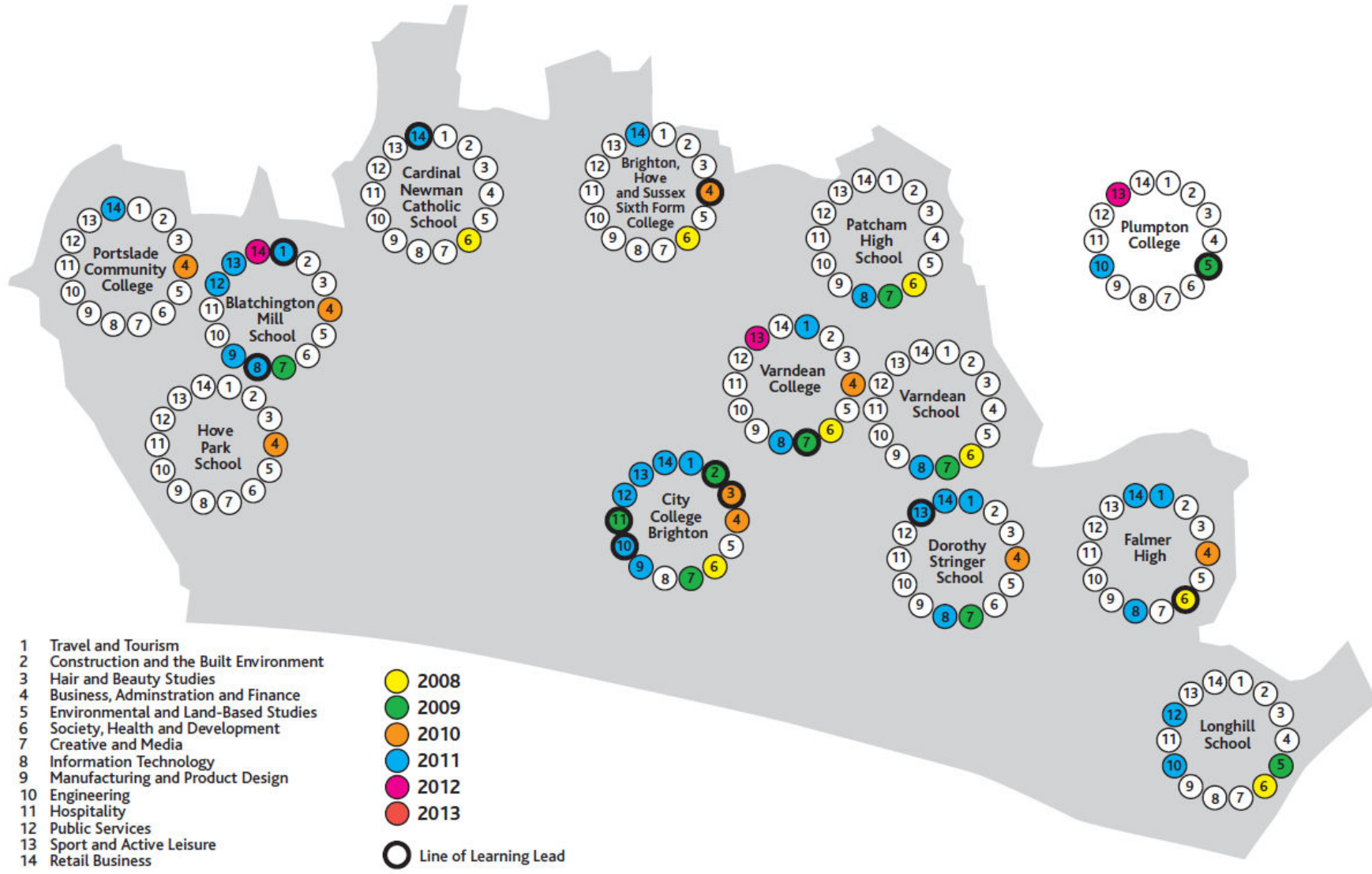

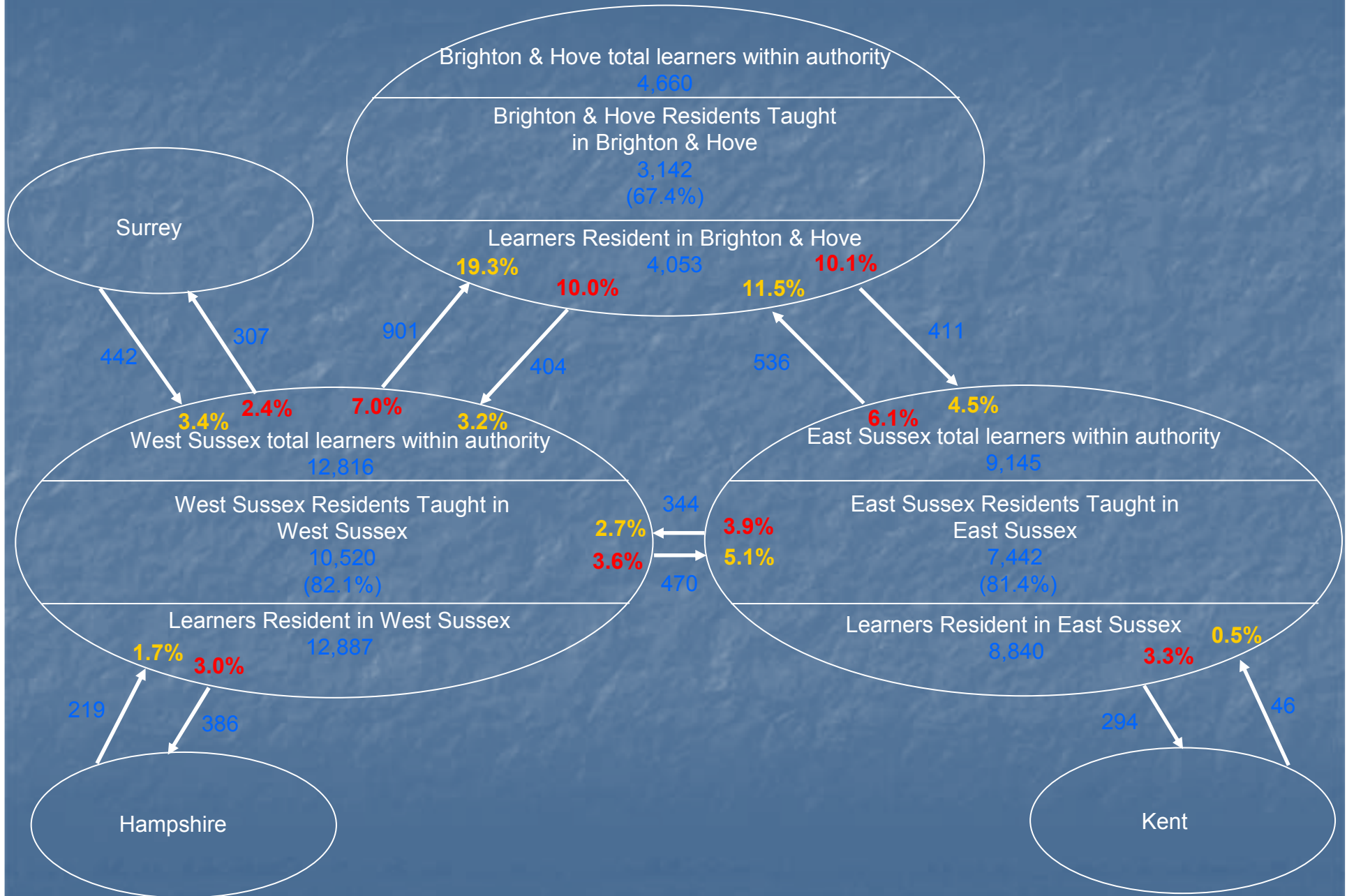
The transfer of responsibilities from LSC to LA
