**Performance of Live Music** - Indoors Usually only played on Basement and Ground floor. Ordinarily performances will last 1 hour interspersed with recorded music.

Monday-Sunday: 19.00-00.00

Seasonal variations: New Years Eve.

**Performance of Recorded Music** - Indoors Recorded music played by means of in-house system using CDs and records. Volumes are preset and under the control of the management.

Monday - Wednesday 10:00 - 03:00, Thursday 10:00 - 04:00, Friday 10:00 - 06:00, Saturday and Sunday: to open at 10:00 on Saturday, and continue until 02:00 on Monday morning (ie 40 hours continuous) Seasonal variations: New Years Eve.

**Performance of Dance** - Indoors This allows for those involved in performance of live music. Monday-Sunday: 19.00-00.00, Seasonal variations: New Years Eve.

**Entertainment of a similar description** - Indoors MCs, DJ performance, cabaret and

karaoke.

These are occasional activities occurring within the general entertainments provided.

Monday - Wednesday 10:00 - 03:00, Thursday 10:00 - 04:00, Friday 10:00 - 06:00, Saturday and Sunday: to open at 10:00 on Saturday, and continue until 02:00 on Monday morning (ie 40 hours continuous) Seasonal variations: New Years Eve.

**Making music** - Indoors Microphones, mixing desk and amps.

All amplified music played on the premises through in-house system and therefore under the control of the management.

Monday - Wednesday 10:00 - 03:00, Thursday 10:00 - 04:00, Friday 10:00 - 06:00, Saturday and Sunday: to open at 10:00 on Saturday, and continue until 02:00 on Monday morning (ie 40 hours continuous) Seasonal variations: New Years Eve.

**Dancing** - Indoors Dancing is permitted throughout the venue, however specific designated non dancing areas on each floor included - Basement - Seating areas, Ground Floor - Raised seating area, First Floor - Beds and tables and chairs.

Monday - Wednesday 10:00 - 03:00, Thursday 10:00 - 04:00, Friday 10:00 - 06:00, Saturday and Sunday: to open at 10:00 on Saturday, and continue until 02:00 on Monday morning (ie 40 hours continuous) Seasonal variations: New Years Eve.

**Other Entertainment falling within Act** - Indoors Provision of a fixed stage on the ground floor and designated area in the basement, demarcated as appropriate and provision of DJ equipment. Recorded music played by means of in-house system using CDs and records.

Volumes are preset and under the control of the management.

Monday - Wednesday 10:00 - 03:00, Thursday 10:00 - 04:00, Friday 10:00 - 06:00, Saturday and Sunday: to open at 10:00 on Saturday, and continue until 02:00 on Monday morning (ie 40 hours continuous) Seasonal variation: New Years Eve.

**Late Night Refreshment** - Provision of a bar menu.

Monday - Wednesday 23:00 - 03:00, Thursday 23:00 - 04:00, Friday 23:00 - 06:00, Saturday and Sunday : to open at 10:00 on Saturday, and continue until 02:00 on Monday morning (ie 40 hours continuous) Seasonal variation: New Years Eve.

**Sale by Retail of Alcohol**

Monday - Wednesday 10:00 - 03:00, Thursday 10:00 - 04:00, Friday 10:00 - 06:00, Saturday and Sunday: to open at 10:00 on Saturday, and continue until 02:00 on Monday morning (ie 40 hours continuous) Variation on New years eve.

**The opening hours of the premises**

Monday - Wednesday 10:00 - 03:30

Thursday 10:00 - 04:30

Friday 10:00 - 06:30

Saturday and Sunday : to open at 10:00 on Saturday, and continue until 02:30am on Monday morning. Variation on New years eve.

### Annex 1 – Mandatory conditions

S 19; mandatory conditions where licence authorises supply of alcohol:

- no supply of alcohol may be made under the premises licence:
  - (a) at a time when there is no designated premises supervisor in respect of the premises, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended:
    - every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

S 21; mandatory condition: door supervision:

- where a premises licence includes a condition relating to security activity, the licence must include a condition that each individual

must be licensed by the Security Industry Authority (there are exemptions re theatre and films and clubs).

**Embedded Conditions:**

**1. Permitted Hours**

Alcohol shall not be sold or supplied except during permitted hours. 7) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day.

**Restrictions**

The above restrictions do not prohibit:

- d) Consumption of alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises.
- e) The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of alcohol so ordered.
- f) The sale of alcohol to a trader or club for the purposes of the trade or club.
- g) The sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces.
- h) The taking of alcohol from the premises by a person residing there; or
- i) The supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
- j) The supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of alcohol so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

**2. Premises with no children's certificate-**

No person under fourteen shall be in the bar of the licensed premises during the permitted hours unless one of the following applies:

- a) He is the child of the holder of the premises licence.
- b) He resides in the premises, but is not employed there.
- c) He is in the bar solely for the purpose of passing to or from some part of the premises which is not a bar and to or from which there is no other convenient means of access or egress.

d) The bar is in railway refreshment rooms or other premises constructed, fitted and intended to be used bona fide for any purpose to which the holding of the licence is ancillary.

In this condition “bar” includes any place exclusively or mainly used for the consumption of alcohol. But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals.

### **5. Recorded Music**

Premises licensed for the sale and supply of alcohol may provide, at any time, regulated entertainment by the reproduction of wireless, including television broadcast and of public entertainment by way of music and singing only which is provided solely by the reproduction of recorded sound.

### **Public Entertainment Licence**

The number of persons permitted on the licensed premises at any one time shall not exceed:-

Basement – 200      Ground Floor – 120      First Floor - 80

Variations to Embedded Conditions:

- a) References to permitted hours removed except where shown.
- b) Public Entertainment Licence: Standard Condition 20.1 (no admission after 01.00) disapplied.

### **Annex 2 – Conditions consistent with the Operating Schedule**

*For the prevention of crime and disorder:*

All door supervisors will be licensed by the Security Industry Authority (SIA).

*For public safety:*

Shatterproof glasses will be used where appropriate.

The CCTV system will be maintained in good working order.

*For the prevention of public nuisance: **None.***

*For the protection of children from harm:*

Persons under 18 will not be allowed on the premises.

Suitable means of identification will be required to be shown by persons appearing to be under 18 as proof of age. Acceptable identification will include a passport, photographic driving licence, or a card under the 'PASS' scheme.

### **Annex 3 – Conditions attached after a hearing by the licensing authority**

1. All outstanding noise control measures must be completed to the satisfaction of the licensing authority and the environmental health department before the variation comes into effect.
2. All external doors and windows must be kept closed during hours of operation, except for access and egress.
3. The licensee must ensure that excessive noise does not come from the premises such as to cause people in the neighbourhood to be unreasonably disturbed.
4. The licensee must ensure that prominent, clear and legible notices are displayed at all exits (and in the outside area) requesting the public to respect the needs of local residents and to leave the premises and the area quietly.
