Thank you for this. Sorry to hear the Paris House is causing upset once more.
Briefly I have copied in from licensing. From memory I think bands may be permitted till 8PM under the existing licence, but this doesn't take away from how noisy and harmful the impact can be. Under the provisions of the Environmental Protection Act 1990 noise nuisance is assessed on the character, duration and frequency of the noise and how it affects a person in their home.
can keep us up to speed on the specifics of the licence as you say there has been a long standing series of complaints from residents, so let me dig some of that out. My educated guess is that you will will most likely be asked by environmental health to make a noise diary by them, so in anticipation of this, can I suggest you keep clear records of times/ noise/ what happened etc.
From a look at the emails on this a key part of resident's issues with Paris House has been vaguely worded, ambiguous and old conditions relating to the licence. I wonder if you can clarify how we would seek to have those updated and clarified? and from licensing copied in too as they have followed this over time too.

I made a noise complaint in January about the pub The Paris House on western road. The reference for the complaint was

A field officer from the council then went to speak to the staff at the Paris house about their noise levels and the situation then improved. You sent me a noise diary in the post but because the volume of noise was now more tolerable and they weren't playing it so loud past midnight as often, we felt there was no need to fill out the diary.

However, over the last month it has gotten worse again. It is again extremely loud several nights per week and often past midnight (Sometimes past 2am). I have tried to call them to ask them to turn their speakers down. They usually don't answer but once they did, the woman who picked up said could not hear me and that I should call back when it's quieter and then hung up. I have also tried emailing them again but no answer.

Could the council get back in touch with them again or, would you be able to send me another noise diary which I will fill out and get back to you.

It's becoming intolerable, we cannot relax in the evenings because it's so loud throughout our house and we can't get to sleep at a reasonable time. We have to wear uncomfortable ear plugs to bed just so we can fall asleep.

Thank you for dealing with it so speedily last time we really appreciated that and had hoped they had understood but it seems not.
