I have just seen a notice that the above premises has applied to extend their licence hours to midnight on specific days of the week.

As a residential neighbour at **REDACTED** I would like to comment:

- Planning permission was awarded on the basis that customers would be able to sample drink on the premises, and the main purpose of the business was retail of their products, not drinking. We have noticed that the premises now supports regular drinkers inside and on the pavement (blocking pavement flow) causing crowds to gather and constant noise. The extension applied for demonstrates that the aim is to become a function facility promoting entertainment and drinking which is not in accordance to the original planning permission.
- During the past few weeks it has been necessary to close our front windows because of the reflected noise into our street, and my wife has had to change bedrooms at 10pm because she was unable to sleep due to the noise and music even with the windows closed.
- There is often noise from patrons departing in particular (loud voices and car doors) already.
- Rustico next door have to close their bifold frontage and stop serving outside by 9pm each night, imposed by planning to protect the neighbours. Why is it not the case at Lost & Found?
- We are aware that number **REDACTED** suffers worse than us, but unlikely to comment.

On the basis of noise issues already experienced, we wish to object to any extension of licence unless there are safeguards put in place to protect residents.
