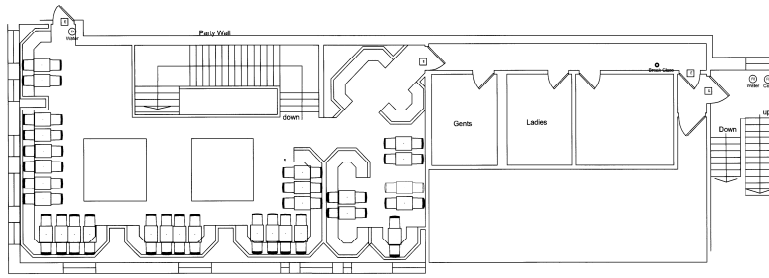

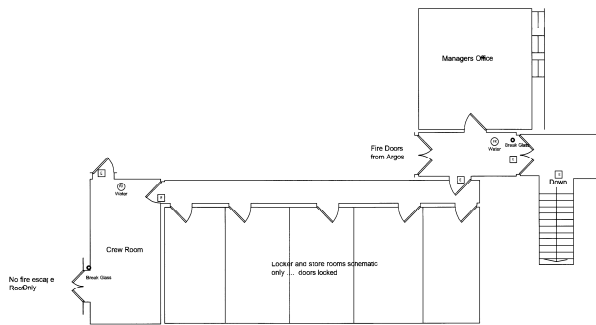

Second Floor

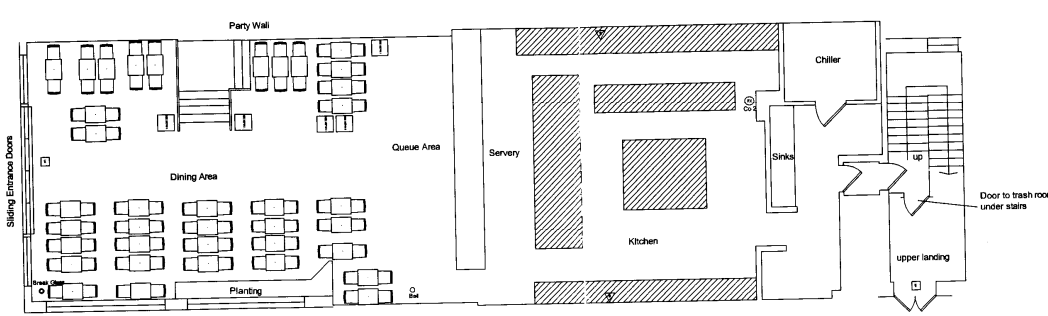
