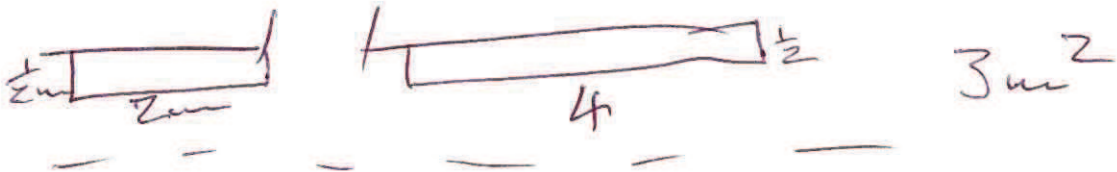

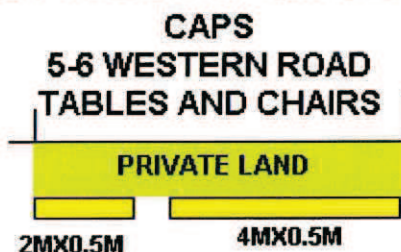

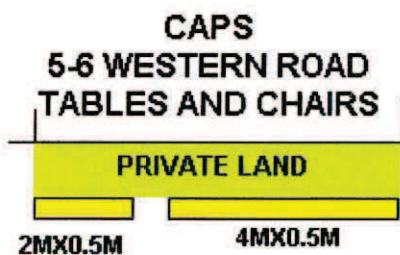

Please find enclosed a copy of a Public Notice. Please can you display this notice for a period of 28 days.

When this period is over, if no objections have been received we will be able to issue you with a licence for your table and chairs.

Your licence will allow you to place tables and chairs in the area of public highway indicated in yellow in the diagram below



The area you are permitted to use covers 3m². This is made up of an area 2m x .05m and 4m x 0.5m, on the public highway. The area must be surrounded by barriers at all times to stop the spread of tables and chairs.

The annual fee for your tables and chairs area will be £60.00. This is based on our pricing structure of £20 per m².

Including the initial application fee of £150 the total amount payable this year is £210.00. We have already received full payment.
